RESOLUTION AUTHORIZING AN APPLICATION TO THE ILLINOIS DEPARTMENT OF TRANSPORTATION'S TRANSPORTATION ENHANCEMENT PROGRAM (ITEP) FOR PEDESTRIAN/BICYCLE FACILITIES

RESOLUTION NO. 2017-11-21-A

WHEREAS, the Village of Pecatonica is seeking \$480,088.32 in funds from the Illinois Transportation Enhancement Program (ITEP) through the Illinois Department of Transportation (IDOT) for Pedestrian/Bicycle Facilities; and

WHEREAS, the Village of Pecatonica, upon award of the ITEP funds, as the lead sponsor shall be responsible for securing local matching funds and/or in-kind services in an amount equaling at least twenty percent (20%) of costs for preliminary engineering, utility relocations (as required), construction engineering, and construction, with eighty percent (80%) of the costs to be funded by ITEP; and

WHEREAS, this Village Board believes it is in the best interests of the Village of Pecatonica to support the efforts outlined herein.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF THE VILLAGE OF PECATONICA, ILLINOIS, that:

- <u>Section 1.</u> This Village Board supports the submittal of an application to IDOT's ITEP program for the expansion of Pedestrian/Bicycle Facilities.
- <u>Section 2.</u> The Village Board affirms its commitment to <u>\$120,022.08</u> in local funding as the required twenty percent match for a \$600,110.40 application for ITEP funding.
- <u>Section 3.</u> The foregoing recitals shall be and are hereby incorporated in this Section 3 as if said recitals were fully set forth.
- <u>Section 4.</u> The provisions of this Resolution are severable and if any court of competent jurisdiction shall declare any portion of this Resolution to be invalid or unenforceable, said decision shall not affect any portion of this Resolution other than the part declared invalid or unenforceable. The Village Board hereby declares that it would have enacted this Resolution even with the invalid or unenforceable portion deleted.
- <u>Section 5.</u> This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
- <u>Section 6.</u> Any resolution or motion in conflict with this Resolution is hereby repealed insofar as it conflicts with this Resolution.
